## The Purpose of Cultivating Human Resources and Educational Research

In the German Language and Literature department, detailed individual guidance is provided in each field of German Language and literature based on the curriculum and corresponding to the aptitude and capability of the students. In the Graduate School First Semester Doctoral Program, we aim to train students to acquire methods for comprehensively understanding, comprehending, and solving research problems through lectures and exercises, thereby fostering human resources with specialized knowledge that can respond to the demands of society in all its various aspects, while taking into consideration the workings of the human spiral than the characteristics of German culture, without being biased toward German language and literature. In the Graduate School Second Semester Doctoral Program, students further refine the specialized skills they developed in the first semester, with the aim being not only to achieve systematic research results, but also to cultivate them into expert professionals and researchers who can be accepted internationally.

(DP4)	on German socio-historical, cultural and linguistic subjects, are posited as the horizontal axis of the curriculum, and "Specialized Lectures" or "Exercises" taught by German instructors are offered without fail.  - In addition to the sequential system in which "Exercises" taught by research supervisors are assigned from the first year, the curriculum is designed in consideration of systematics so that, of the 32 credits required for completing the course, 8 credits are allocated from "Exercises" taught by academic supervisors, 4 are allocated from "Specialized Lectures" or "Exercises" taught by German instructors, and 20 are allocated from various "Specialized Lectures" or 4 of which are allocated by academic supervisors). The curriculum is therefore designed to have a balance of <8 credits from the "Exercises" plus 4 from the "Specialized Lectures" or "Exercises" held by the German instructors for a total of 16°, with canother 16 credits from the various "Specialized Lectures" or "Exercises" held by other instructors. In addition, "Specialized Lectures" given by partitime lecturers invited from other universities are offered for up to 4 credits to meet the needs of research guidance. For students in the Special European Course of the Department of German in the Faculty of Humanities at Fukuoka University, screening is conducted strictly in accordance with the entrance examination requirements, with regard to grades based on the regulations concerning the early graduation system, and with regard to the applicant's statement of purpose and research plan disclosed in the interview.

In addition, as the vertical axis of the research guidance system (research work), the curriculum is organized to ensure the vertical and horizontal interlink with consideration given to sequentiality by arranging "Exercises" as compulsory subjects in each year to provide guidance in writing a master's thesis in accordance with the research problem, while classes and individual research guidance are provided to foster international citizens who can utilize their specialized knowledge and advanced skills in order to contribute to intercultural understanding.  - Individual course guidance will be provided on April 1 of each academic year, and attendance at the "Research Ethics e-Learning Course" will be mandatory for each academic year.
